



2019 IMPORTANT TAX REPORTING INFORMATION

This letter contains important tax information specific to your U.S. Global Investors Funds. Please consult your tax advisor and refer to this newsletter when preparing your 2019 tax return. We believe we have provided the detail necessary to complete your 2019 tax returns. Qualified Dividend Income

Qualified dividend income (“QDI”) is taxed at the lower long-term capital gain rates through 2019. The mutual fund may pass through any QDI it receives from stocks in the fund’s portfolio. QDI is reported to you on Form 1099-DIV, Box 1b.

The QDI amount in Box 1b will only apply to you if you have held a fund for more than 60 days during the 121-day period beginning 60 days before the date of the distribution. To assist you in determining whether you have met this holding period requirement, the distribution dates for our equity funds are listed below.

If so, multiply the income percentage listed in the chart below by the amount in box 1a of your Form 1099-DIV to determine the amount of exempt interest.
